



## **Next Step Ministries St Augustine, TX - Disaster Relief Mission Trip**

Date: July 22-28, 2018

Grades: 7th-10th

Cost:

- Deposit of \$100 due with registration
- **Early Bird Price \$419 (Deposit must be made by February 15th)**
- Trip cost for deposits received after February 15 is \$619
  - 2nd payment due May 1 - \$300
  - Final payment due July 1, 2018

Deposits and fees for the mission trips may be made by credit card online or by cash/check made payable to Redeemer Covenant Church. Any amounts paid for trips will no longer be considered as "contributions" to the Student Ministry Fund. This eliminates any restrictions on the monies given and will be bound by the cancellation policy for each particular trip.

Deadline for cancellation and full refund is March 11, 2018. After March 11, any money received will be considered a donation or applied towards a future mission trip.
